**CHIEF SECRETARIAT (ANIMAL HUSBANDRY)**  
**NOTIFICATION**

In exercise of the powers conferred by Rajiv Gandhi Institute of Veterinary Education and Research in clause (n) of sub-(rule 2) of rule 11 of the Rules and Regulations of the Pondicherry Veterinary College Society and with the approval of Board of Governors meeting held on 19.06.2025, the Board of Governors of the Rajiv Gandhi Institute of Veterinary Education and Research, Puducherry, hereby makes the following rules regulating the method of recruitment to the post of Professor and Associate Professor in the Rajiv Gandhi Institute of Veterinary Education and Research, Puducherry, namely:-

1. *Short title and commencement* - (1) These rules may be called the Recruitment Rules, 2026 for the post of Professor and Associate Professor in the Rajiv Gandhi Institute of Veterinary Education and Research, Puducherry.  
  
(2) They shall come into force from the date of their publication in the official gazette.
2. *Number of post, its classification, Pay Band and Grade Pay/Pay Scale* – The number of the said post, its classification and the Pay Band and Grade Pay/Pay Scale attached thereto, shall be as specified in columns (2) to (4) of the schedule annexed hereto.
3. *Method recruitment, age-limit and other qualifications* – The method of recruitment to the said post, age-limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (12) of the said schedule.
4. *Disqualifications* – No person, -
  - (i) Who has entered into or contracted a marriage with a person having a spouse living : or
  - (ii) Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Board of Governors, may if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

5. *Power to relax*.- Where the Board of Governors is of the opinion that it is necessary or expedient so to do, may in consultation with the Department of Personnel and Administrative Reforms (Personal Wing), Government of Puducherry and with the approval of the Government of Puducherry, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
6. *Saving*.- Nothing in these rules shall affect the reservations, relaxation in upper age – limit and other concessions required to be provided for the scheduled castes / scheduled tribes and other special category of person in accordance with the orders issued by the Government from time to time in this regard.
